

Thresholds for assistance are considerably lower than entry into a PCA program.

The **PERFECT MATCH for clients that need help with ADLs, but will not meet the criteria for PCA**



Service must be ordered by the consumer's PCP.

We conduct an initial assessment and create a custom **Plan of Care based on diagnoses and consumer needs.**

➤ If you have a consumer that needs help with at least one ADL or reminders/queuing for ADLs,

we can enroll them in the GAFC program. Consumers with behavioral health or physical disabilities often need our assistance.





ADL – Activities of Daily Living

Personal care tasks that are part of the consumer's daily routine of self-care



- Eating
- Toileting
- Dressing

- Bathing
- Mobility Ambulation
- Transferring

➤ IADLs - Instrumental Activities of Daily Living Tasks related to independent living

- Household Management
- Laundry, Shopping
- Meal Preparation and Clean-up
- Medication Reminders and Appointment Reminders
- Adaptive Device Maintenance

AFC Caregiver Service Level 1

- ✓ Hands-on (physical) assistance with one or two of the activities*
- ✓ Requires cueing and supervision throughout one or more of the activities*

*Described in 130 CMR 408.416



AFC Caregiver Service Level 2

- Hands-on (physical) assistance with at least three of the activities*
- Hands-on (physical) assistance with at least two of the activities* and
- Management of behaviors that require frequent caregiver intervention*
 - o Wandering
 - o Verbally Abusive
 - o Physically Abusive
 - o Socially Inappropriate
 - o Disruptive
 - o Resisting Care

Group Adult Foster Care (GAFC) – Home Health Aide Service

Up to one hour of care **5 - 7** days a week by:

- **Home Health Aide (HHA)** or
- **Certified Nursing Assistant (CNA)**

Delivered to consumer in their home by a **Multi-Disciplinary Team:**

- o **Direct Care Aide/Home Health Aide - Assist with ADLs and IADLs**
- o **Supervising Licensed Nurse**
- o **Care Manager**
